- 1. The Chartered Accountants firm should be: (i) listed as Category A with satisfactory QCR rating with State Bank of Pakistan, registered with ICAP and on Active Income Tax Payers List of FBR and SRB (for Sindh Sales Tax). (ii) The name of the firm should also be borne on other elite panels of auditors in Pakistan. (iii) Applicant should have at least 20 years experience in undertaking such assignments. (iv) the firm should have reasonable experience of auditing NPO/NGO/Government entities and Public Sector Entities functioning under the PSE (Corporate Governance) Rule-13.
- 2. The intending firms shall attach relevant documents or equivalence certificates. (as mentioned in Bidding Document)
- 3. Detailed bidding document and other related information can be downloaded from the website of SPPRA as well as www.shcc.org.pk or obtained from the office of the Directorate of HR & Admn (SHCC) at the address given below on any working day w. e. f. 22nd May, 2023 between 9:00 am to 5:00 pm by paying an amount of Rs. 3,000/- (Non-Refundable) in the shape of Pay order in favor of "Sindh Healthcare Commission" till 7th June, 2023.
- 4. Least Cost Based Selection Method (LCBS) will be used for open competitive bidding, the interested firms are requested to submit their sealed bids accordingly.
- 5. Bidding procedure i.e. Single Stage-two Envelopes will be followed.
- 6. Bid Security equivalent to 2.0% of total bid value in the form of Pay order / Demand Draft / Banker's Cheque in favor of "Sindh Healthcare Commission" shall be submitted with the bid. The Bids without the Bid Security will be rejected.

7. SHCC reserves the right to reject any or all bids without assigning any reason and annul the bidding process, in accordance with SPPRA rules.
