- After submission of online application, candidates may download system generated challan of **Rs. 650/ (Rupees Six Hundred & Fifty only)** and deposit it in any branch of Bank as mentioned in <https://www.nts.org.pk>
- Candidates already in government services must apply through proper channel. Applications without NOC will not be entertained.
- Providing fictitious, exaggerated or misleading information shall result in rejection of application & termination of employment at any stage.
- No TA/DA will be given for appearing in test/interview.
- Only shortlisted candidates will be called for test/interview.
