- 1. The Sindh Healthcare Commission intends to procure stationery and sealing material from a reputable and experienced **supplier**, must have Valid NTN, GST, SRB, Professional Tax and any other valid Tax Registration Certificate required by law in force and must be on Active Taxpayers List.
- 2. The intending firms shall attach relevant documents or equivalence certificates. (as mentioned in Bidding Document)
- 3. Detailed bidding documents and other related information can be downloaded from the website of SPPRA as well as <u>www.shcc.org.pk</u> or obtained from the office of the Director Human Resource & Administration (SHCC) at the address given below on any working day w. e. f. 1<sup>st</sup> Jan, 2024 between 9:00 am to 5:00 pm by paying an amount of Rs. 3,000/- (Non-Refundable) in the shape of pay order in favor of "Sindh Healthcare Commission" till 10:00 AM 18<sup>th</sup> Jan, 2024.
- 4. Bidding procedure i.e. Single Stage-one Envelopes will be followed.
- 5. Least Cost Based Selection Method (LCBS) will be used for open competitive bidding, the interested firms are requested to submit their sealed bids accordingly.
- 6. Samples for each item quoted shall be produced before Procurement Committee.
- 7. The Bidder must have local presence in Sindh
- 8. Bid Security equivalent to 2.0% of total bid value in the form of Pay Order / Demand Draft / Banker's Cheque in favor of Sindh Healthcare Commission, Karachi shall be submitted in technical bid envelope. The Bids without the Bid Security will be rejected.
- 9. SHCC reserves the right to reject any or all bids without assigning any reason and annul the bidding process, in accordance with SPPRA rules.
