


The bids were evaluated, one of the bidders, M/s ZAS Interiors and Décor was found to have provided incomplete documentation required under clause 7 "**Tender Eligibility**". The Procurement committee decided to disqualify the bidder M/s ZAS Interiors and Décor due to incomplete submission of documentation required for tender eligibility as mentioned in Clause 20.4 '**Bid Evaluation Criteria**'.


The Procurement Committee after reviewing the bids has found the following bidders successful against each item/job.
