32	Fees for Letter of Intent (LOI), Determination to establish HCE (After submission of prerequisite documents).	10,000

Note:

1. The initial Inspection is covered under the RL fees. If the Establishment fails to qualify during first Inspection, a Maximum of two follow-up Inspections may be conducted. If the Establishment does not qualify after the second follow-up, the Regular License application will be rejected. In such cases, the Management of the HCE must submit a completely new application, along with the requisite fees, to re-initiate the process.
2. The Urgent Processing Fee is a Mandatory surcharge that must be paid in addition to the standard Registration & Licensing Fee.
